Introduction to Kavana FX

This cookie policy pertains to the website<u>www.Kavanafx.com</u> and all its associated subdomains and mobile applications managed and operated by Kavana FX Ltd and Kavana FX Corporation.

In its capacity as a financial services firm, Kavana FX (herein referred to as "the Company") abides by the regulations outlined in the Cookie Policy (hereinafter the "Policy"), detailing how cookies are utilized to enhance user experience while browsing our website and enabling continuous improvement.

We highly prioritize your privacy and are dedicated to equipping you with the necessary information and tools to effectively manage your cookies.

Understanding Cookies, integral to website functionality, are small text files stored on your computer or mobile device upon visiting a website. They serve to optimize website performance and provide information to site owners.

Distinguished from session cookies, persistent cookies remain on your computer beyond browser sessions, facilitating improved user experience through anonymized statistical analysis of browsing behavior.

Cookie Analysis at Kavana FX

Kavana FX website utilizes three main types of cookies, each serving distinct purposes as elaborated below:

- 1. Necessary Cookies: Essential for core website functionalities such as navigation and secure field access. These cookies do not necessitate user consent but can be disabled through browser settings, albeit potentially affecting website performance.
- 2. Analytical Cookies: Employed to gauge and enhance site performance through anonymous user interaction reports.
- 3. Marketing Cookies: Tailored to deliver personalized user experiences and targeted advertisements by analyzing user activity, thereby optimizing marketing endeavors.
